Please note the points given below:-

- **Negligence and failure of the parent of UKG to follow the procedure for admission, clearing the dues for the current session and admitting their ward to Class I on the above stipulated date and time will result in losing the seat for the said class.**
- **The candidate shall forfeit his/her claim for admission. The offer of admission shall stand cancelled ipso facto and no correspondence in this regard shall be entertained.**
- The detailed fee structure for the upcoming session (2024 - 25) is available on the school website.
- Complete the necessary procedures and clear the dues (if any) before the date of admission.
- Both the parents should be present to fill the admission form of Class I.
- Submit a complete and duly signed Admission Form along with the required documents attested by Class A gazetted officer (**Date of the Birth Certificate of the Candidate and Aadhaar Card of the Candidate and parents**) along with a **recent passport size photograph of the candidate, mother and father (one each)**.
- Correct information must be given in the admission form.
- The date of birth certificate should have the name of the child and the parents written on it.
- Date of birth, spellings of names and surnames must be correctly written. No change or correction will be entertained once the entries are done in the school records. Therefore, change of name or surname should be correctly thought of before making the entries in the Admission Form.
- The first instalment Rs. 20570/- is to be paid in the bank by 26.03.2024 or within two days of receiving the fee slip.

This National Education Policy envisions an education system rooted in Indian ethos that contributes directly to transforming India, that is Bharat, sustainably into an equitable and vibrant knowledge society, by providing high-quality education to all, and thereby making India a global knowledge superpower. The Policy envisages that the curriculum and pedagogy of our institutions must develop among the students a deep sense of respect towards the Fundamental Duties and Constitutional values, bonding with one's country, and a conscious awareness of one's roles and responsibilities in a changing world. The vision of the Policy is to instill among the learners a deep-rooted pride in being Indian, not only in thought, but also in spirit, intellect, and deeds, as well as to develop knowledge, skills, values, and dispositions that support responsible commitment to human rights, sustainable development and living, and global well-being, thereby reflecting a truly global citizen.
